SPECIAL NEEDS PLAYER FEES

Fees listed for Special Needs Players are applicable only to players registering in a Football NSW approved Club or Association based program which operates as part of the Football4All state program.

All Special Needs Programs operating within Football NSW must be approved by the local Association and by Football NSW. Approved Special Needs programs are listed on the Football NSW website under Game Development.

PLAYER CONTRIBUTION (PERSONAL INJURY INSURANCE)

Player contributions towards the Personal Injury Insurance are based on a Junior and Senior category.

For purpose of the Personal Injury Insurance only,

- a Junior is defined as any player between the age of five (5) or turning five (5) up to and including the age of eighteen (18) or turning eighteen (18) in the year.
- an Adult is any player aged nineteen (19) or above.

SCHEDULE FOR ASSOCIATION PAYMENT OF FNSW FEES

- 60% of payment to be made by Thursday, 30th April 2015.
- The first Tax Invoice of 60% will be issued based on 2014 registrations.
- Balance of payment to be made by Friday, 31st July 2015.
- Registration fees will be calculated off MyFootballClub data as at the 30th of June 2015. Status returns where applicable, to be completed and returned by Friday, 10th July 2015.
- Late lodgement of final Status Return will be fined \$200.
